In response to the Court's written question no 1, the representative of the Kingdom of the Netherlands indicated that no decision had been made by a competent Dutch authority regarding any investigations or prosecutions for a terrorist act in connection with Mr Sison in the period indicated in the Court's question.

In response to the Court's written question no 3, the representative of the Council indicated that no criminal charges or other investigations or prosecutions brought against Mr Sison in the Philippines were taken into account by the Council when updating the lists laid down in Common Position 2001/931/CFSP and Regulation No 2580/2001.

The representatives of the parties replied to questions put by the chamber.
